

### **A. Position Name – Young Professional (MSME, Enterprise Development, Marketing, MIS, Quality Control, Social Media)**

#### **Essential Skill Sets -**

- Excellent communication (oral and written) skills in English and Hindi.
- Robust Knowledge of MS Office (Excel, PowerPoint, Word)
- Virtual Meeting Apps and Time/ Calendar Management
- Networking/ Collaboration and Interpersonal Skills

#### **Roles and Responsibilities:-**

The Young Professionals recruited for this position will work closely with the District Industry Centre (DIC) and Directorate of Industries in Bihar. Their primary responsibilities will include:

- Supporting the implementation of government schemes related to MSME such as the Raising and Accelerating MSME Performance (RAMP) scheme, which aims to promote entrepreneurship and micro-enterprises in the MSME sector.
- Providing technical assistance to MSME units in the district.
- Conducting research and providing analysis to identify opportunities for growth and development in the MSME sector. A case study of successful work related to MSME will also be prepared by them.
- Organising training and capacity-building programs for entrepreneurs and workers in the MSME sector.
